# Regular Board Meeting Board of Trustees

Mayor M. Katherine Davin, and Trustees William Reeves, Lloyd A. Green, Mary Lou Wilson, Village Attorney Laura Jane Poyzer. Absent, Trustee Daniel Condon. Present:

2 Min. Mayor Davin opened the meeting with a moment of silence. Silence:

Vouchers: Motion by Trustee Green, 2nd by Trustee Reeves and carried, to approve payment of the vouchers in the amount of \$128,163.94, and authorize the treasurer to issue checks in this amount.

Minutes: Motion by Trustee Reeves, 2nd by Trustee Green and carried, to accept the minutes of the previous meeting.

Robert Peterson, Chairman of the Wayne County Planning Board, New Fed. informed the board that the Federal Government will be again Funds: asking for Community Development Act Applications. Regulations of the Community Development Act of 1974 have been revised. Fewer projects will be funded but amounts for projects will be larger and expanded. The County of Wayne will be submitting applications using a number of communities' priorities to combine into one large county project. The same items are available with the exception, as before, of Governmental Buildings. 75% of the funds must qualify for or benefit the low or moderate income levels.

Hearings: Mr. Peterson advised that two hearings must be held, but prior to the hearings, notices should be inserted in the Palmyra Courier-Journal as well as the Timesaver, requesting the public to attend the hearings and to make suggestions for use of the funds that may be available.

Title #1 of 1977, Community Development Act would grant housing improvement as well as municipal improvement, excluding construction of a Village Hall. Most villages, according to Mr. Peterson, are asking that the Wayne County Planning Board make application in their behalf, with the request that there be more public participation.

On motion by Trustee Wilson, 2nd by Trustee Green and carried, Hrng. the date of February 7, 1978 at 4:00 P.M. and February 7, 1978 at 7:30 P.M. was set for Public Hearings in the Justice Room of Date the Village Hall.

Bruce Wideman, coordinator of the restoration of the former Erie Canal Area during the last two years, informed the board that if the State of New York Department of Waterways & Transportation, fills in the area between the north bank of the former Erie Canal and the south bank of the present Barge Canal with the sludge dredged from the Barge Canal, there will be no trees, bushes, birds, wild flowers, or animals to habitate this area. He solicited the endorsement of the entire board in relation to his continuing effort to "block" the dumping of the sludge in the wild-life area. Trustee Wilson commented that it was her feeling that this matter should be pursued. Mr. Wideman further commented that the Town Board of the Town of Palmyra has gone on record indicating that they would be in favor of preserving this area. Mr. Wideman advised that three years ago the County Planner had designated the area from Church Street to the west, where now a Canal Park at the Canal Locks is located, would become a walk and bigycle area for pedestrians. In the interim, it was learned that the Department of Transportation had designated the area to become a "dumping ground" for the

sludge. Mr. Wideman felt that if it might be possible to obtain the services of Harnish & Lookup, Engineers, Newark, N.Y., for a nominal fee, it might be determined where the "North Blue Line" may be located. After this has been indicated, it would be possible to evaluate whether or not the State were dumping on Village property. If such were the case, other areas would have to be found by the State for dumping.

Mr. Wideman also asked that in the future, prior to the sale of any land in the former Erie Canal Bed, to a private property owner, that a public hearing should be held.

New Firehse: Mayor Davin commented that Iverson Construction, contractors for the new firehouse, have asked that a determination be made relative to a small drain pipe or burm that appears to have surfaced in the vicinity of the proposed construction. Iverson has indicated that they would like to be able to divert it into some other area.

Police Dept.:

Trustee Reeves interjected that since October 10, 1977, the Police Department has been operating with four (4) full-time patrolman and one (1) part-time patrolman. Trustee Reeves continued, advising that, after discussing the workability of this arrangement, with Police Chief Henry, and after considerable thought on the matter, it is the consensus of their opinion that the Police Department has been functioning effectively. Trustee Reeves further suggested that it would be advisable

Trustee Reeves further suggested that it would be advisable to eliminate one full-time patrolman position, plus sell the 2nd Police Car as soon as the new one arrives. This, he added, would result in a considerable saving to the taxpayer and perhaps, with the saving of these funds, it would be advantageous to promulgate the study of a Village Manager form of government.

Silence: Mayor Davin opened the meeting with a two minute silence.

Minutes: Motion by Trustee Reeves, 2nd by Trustee Condon and carried, to accept the minutes of the previous meeting.

Vouchers: Motion by Trustee Wilson, 2nd by Trustee Condon and carried, to authorize the treasurer to prepare checks in the amount of \$19,584.35 for vouchers as presented. Leak Detector:

Hiram Van Etten, Operator of the Water & Sewer Plants, discussed the need for a Leak Detector. Mr. VanEtten commented that two years ago a survey was made by Heath Consultants, at which time, with their equipment, numerous leaks within the village street transmission lines were found, many of which would not have been noticed without the instrument.

Trustee Condon advised that he had conferred with Nelson Contract: Cook, Councilman for the Town of Palmyra, who indicated that the Town of Palmyra would present a water contract for approval to the Village Board. Previous contract expired on November 30, 1977.

Tn.Req. for Water:

Trustee Condon commented that Nelson Cook, Councilman for the Town of Palmyra has asked that the Village of Palmyra write . a letter to the Town which would indicate that the Village of Palmyra would furnish up to 50,000 gals. of water per day to the Town of Palmyra for a new proposed district on Route #31, east of the Village limits of the Village of Palmyra. Board authorized the clerk to prepare such a letter to be sent to the Town.

Retire. H. Van Etten:

Trustee Condon advised that Hiram VanEtten, who has been operator of the Water & Sewer Plants since 1964, will be retiring as of March 30, 1978. Trustee Condon commented that Mr. Van Etten is entitled to a month's vacation and would, therefore, like to be relieved of his duties as of March 31, 1978, allowing the month of April for vacation. The following resolution was proposed by Trustee Condon, 2nd by Trustee Wilson: WHEREAS, Hiram VanEtten, operator of the Water & Sewer Plant has advised that he will retire as of April 30, 1978, and, WHEREAS, Mr. VanEtten has indicated that a month or 4 weeks vacation would be due him,

BE IT RESOLVED THAT, Mr. VanEtten will complete his duties at
the Water & Sewer Plant as of March 31, 1978, and shall receive vacation pay for the month of April, 4 weeks, 1978. Vote:

Mayor

Mayor Davin complimented Mr. VanEtten for his years of service Comments: with the Village of Palmyra and for his conscientious concern for the functioning of both the water and sewer plants over the years, not only for an economic standpoint, but also for the proficient method of operation.

H. Kruger

Trustee Condon advised that he had conferred with Harold Kruger Appoint .: who has been an employee of the Village of Palmyra for the last ten years as an assistant in the water and sewer plant. Mr. Kruger, he advised, has passed the necessary tests of Civil Service and attended both Water & Sewer Schools as prescribed by the State of New York to allow him to be classified as an Operator of either plan. Trustee Condon advised that he would like to recommend the appointment of Mr. Kruger to replace Mr. VanEtten as of March 31, 1978.

Resol.to Appoint:

The following resolution was proposed by Trustee Condon, 2nd by Trustee Reeves: WHEREAS, Mr. VanEtten, operator of the Water & Sewer Plant will retire as of March 31, 1978,
BE IT RESOLVED THAT, Harold Kruger, Assistant to the Water & Sewer Plant Operator for the last ten years, shall be appointed Water & Sewer Plant Operator as of 3/31/78. Vote:

Vacancy Wat. & Sewer:

Trustee Condon advised that he had received an application from Bradley Persyn, Sodus, New York, who is interested in the Trainee Position. Clerk commented that under the rules of the Union Contract, it would be required that the position be posted. In addition, it would be suggested that an ad be placed in the newspaper advising an opening in the department, for any who might wish to apply.

Plan. Brd.:

Board agreed.

Trustee Condon advised that the Planning Board is working on the Environmental Quality Control. They are studying herbicides and pesticides as these might affect the environment. P, ant House: Trustee Condon informed the board that the Filter Plant House, living quarters for the Water Plant Operator, needs a new roof on the back. In addition, the cellar wall, since the paving of Spring Street, seems to gather water which seeps into the cellar. Trustee Condon suggested that this work be done prior to the Krugers moving into the house. Board agreed.

Finger Lakes Water Mtg.:

Trustee Wilson commented that she had attended the water meeting with Hiram VanEtten. The discussion or speaker enlightened the group about the State Retirement. The next meeting will be on funding water works.

Arbitration:

Mayor Davin advised that the Village of Palmyra has received no official word from the arbitrator regarding the recent R. Mingo Case of the Police Department. Mayor Davin advised that she had prepared a resume of her feelings in the matter and would like them spread in the minutes:

TO WIT:
"The recent ruling by the labor arbitrator in the case involving Robert Mingo, is another example of how villages such as Palmyra are gradually loosing their right to self-determination and municipal control.

"The Village has been told, through the representative of CSEA, that we were wrong in suspending Mr. Mingo for his disregard of certain rules of conduct that had been adopted by our Police Department. In essence we have been told we do not have the right to adopt a code of conduct for village employees. As the chief elected administrative officer of the Village of Palmyra, I protest this situation and finding most vigorously.

"I hold it to be totally wrong when the Village, as the employer, has little or no say over who is to work and not to work for the Village. Mr. Mingo was dismissed from his position as patrolman following his disobedience of prescribed departmental rules and conduct deemed not proper for a policeman. An internal in-vestigation determined the situation and Mr. Mingo never denied he had broken the rules. Following his suspension, his union chose to challenge the village's right to make and enforce those rules. And I hold the outcome of that situation to be unjust and unfair to the taxpayers of this village. I am not in favor of binding arbitration.

"It will cost the Village several thousand dollars before we are finished with this matter. These costs, which are not totaled yet, were incurred because we had to hire a labor relations attorney from Buffalo. We have no provision in our budget for this type or size legal fees and as a result we will have to adjust or cut services elsewhere.

"I believe in the tenets of the American labor movement and I want all employess of the Village to have the basic rights and just wages their positions deserve. But I also believe the Village, as an employer, deserves similar rights. We should have the right to hire and fire employees if circumstances warrant. In the case of Mr.
Mingo, I believe the decision of Chief Henry and
Police Commissioner Reeves was correct and should have been sustained.

Arbitration: "It is apparent we are the target of a crusade by the CSEA and I believe we are being singled out as a test for the union to use as a success story. The union's success is the taxpayer's loss and will continue to be a loss unless we stem this unfair system of Binding Arbitration.

"Stemming this system will not be easy because both our elected representatives in Albany, Assemblyman Hurley and Senator Warder, supported this bill prior to its signing by Governor Carey. It is a serious infringment on the rights of the village and its residents.

"The events surrounding this situation and the subsequent decision make it evident more than ever that a fully staffed police department for a village such as Palmyra is fast becoming a service we cannot afford. If the control of this department is de facto being taken from us, it is obvious we will have to take other measures to control our rights as employers and fiscal officers of the village. It appears this ruling is forcing us closer to a county-wide police department, as advocated in the Wayne County Police Study.

"There seems little else we can do. If we are going to be forced to accept employees we do not desire or deem suitable for a position, then we will have to begin a program to curtail services we cannot afford or raise taxes to pay for them. Neither option is desirable to me. But the alternatives are very clear and our hand is being forced. Our responsibility is to the people of Palmyra first and not a union or the State Government."

Library Request: Mrs. Cass Vande, President of the Palmyra Library Association and Mrs. Nancy Rubery, Librarian, informed the board that it was necessary to take some \$10,000. from the endowment of the library to take care of some of the necessary repairs. Library services have nearly doubled, including help. A ramp for the handicapped is desired plus wiring must be replaced. An estimated cost would be some \$5,000. For this reason, they indicated, they are asking the Village to appropriate \$7,300. in the budget for the library.

Mrs. Vande commented that there is a collection of historical facts, which should be filed, and cataloged. The cost to microfilm together with a cabinet could be some \$3,500. Several other members of the Library Board appeared with Mrs. Vande and Mrs. Rubery to bolster their pleas for additional funds.

Fire Dept.:

Trustee Wilson advised that the pumper tank has been plugged a number of times but it has now come to the point where this is no longer possible. Trustee Wilson indicated that this piece of equipment is in use most of the time. Fire Chief White has suggested that a new tank be obtained which would cost some \$2,600.

The following resolution was proposed by Trustee Wilson, 2nd by Trustee Condon:

WHEREAS, it is expedient that a new water tank be purchased for the 1960 pumper,

BE IT RESOLVED THAT, Chief White shall be instructed to make such a purchase for the safety and efficiency of the fire fighting apparatus, and,

BE IT FURTHER RESOLVED, that funds for payment of the tank shall be withdrawn from the Capital Reserve Fund Fire in the amount of \$2,600.00.

The following motion was proposed by Trustee Wilson, 2nd by Trustee Condon:

Members: WHEREAS, on the recommendation of the Board of Fire Commissioners the following have been named for the fire department, BE IT RESOLVED THAT Glenn H. Bullock, 327 Vienna Street, and Daniel Shoemaker, 404 Canal Street, shall be recommended for membership following the prescribed program of the department.

Unanimously approved.

Sludge:

Canal Bruce Wideman, Zoning Officer, and coordinator of the Erie Canal Beautification Project on Church Street, advised that the permit obtained by the State of New York for the deposit of sludge dredged from the Barge Canal and dumped into the former Erie Canal bed, had expired as of December 31, 1977. He advised it will be required that a public hearing must be held before another permit can be issued.

Mayor Davin commented that she had had many calls regarding the Removal: removal of snow on sidewalks, especially where it is necessary for children to walk and who are in many cases now forced to walk in the street. A special bad spot, she indicated, was on West Jackson Street, in front of the property owned by the Fair Association. Clerk was asked to write a letter to Fair Associa-Mayor urged property owners to remove snow from walks.

Drive:

Prospect Mayor Davin commented that she would like Trustee Green to investigate the possibility of widening or lowering the area of Prospect Drive in view of the many recent accidents on the curve or brow of the street.

Conifer Dev. Purch.

Mayor Davin advised that she had received a purchase offer from Conifer Development, 183 East Main Street, Rochester, New York, in the amount of \$17,800. for the parcel of land on the north Offer: side of Canal Street, opposite the area on which Conifer Development is presently constructing senior housing known as "Towpath Manor". She added that HUD would give grant funds to Conifer Development if they owned the lot.

Mayor Davin advised that there would be an inspection of Towpath

Manor on Thursday, February 9, 1978.

Firehse:

rehse: Robert Sherman, architects, for the proposed firehouse, advised by letter that they had dug into the old canal bed. It was filled with various types of bricks, pieces of cement etc., all of which was not satisfactory for laying stable posts. He advised that he felt that steel casings would be better than fill at this time.

Comm.

On motion by Trustee Wilson, 2nd by Trustee Condon and carried, Ctr. Mayor Davin was authorized to sign the contracts between the Contract: Town of Palmyra, Community Center and Village of Palmyra, with the Town of Palmyra contributing some \$8,000. and the Village of Palmyra as the paying agent.

Police Report:

On motion by Trustee Condon, 2nd by Trustee Wilson and carried, the Police Report for the month of January, 1978 was accepted. Highlights of the report revealed 112 complaints with 25 accidents investigated, along with 6 cited for Petit Larceny, and 37 apprehended for Illegal Parking. Total fines and bail forfeitures amounted to \$90.00.

Firehse: Clerk advised that the New York State Electric & Gas has approved gas service for the new firehouse, but service should be initiated by July 1st. If not, a new application must be submitted.

Election Inspec:

The following motion was proposed by Trustee Wilson, 2nd by Trustee Condon: WHEREAS, on the recommendation of the Democratic Party, names have been submitted for election inspectors, and on the recommendation of the Republican Party, names have been submitted for election inspectors, BE IT RESOLVED THAT, the following Democrats shall be named: Nora O'Brien, John Rigney, with Harriett Mahoney and Ann Guest as alternates, and the Republican inspectors shall be Elizabeth Schrader and Lucille Clark with an alternate, Cora Sampson. Vote:

Unanimously approved.

Blue Line Survey: Clerk advised a letter was received from Harnish & Lookup, Newark, New York, advising that a fee of \$630.00 would be feasible for a new survey of the north "Blue Line" of the Village. Board advised that in view of the proceedings, which would require a public hearing before the New York State Department of Transportation could again dump sludge into the old Erie Canal Bed, clerk should write Harnish & Lookup to delay making the survey until something definite is decided regarding a public hearing.

Speed W.Main: Trustee Condon commented that the 55 Mi. Per Hour Speed Sign has not been moved farther to the west. Clerk asked to again contact N.Y.S. Dept. of Transportation.

Anti-Rec. Fds.: Clerk advised Village of Palmyra has received \$3,214.00 in Anti-Recession Funds from the State of New York. This, she advised, is a one time thing. Funds are to be used for payroll or could be used by village for payment of retirement. Clerk advised that the anticipated bill for retirement due in May for Village employees will be some \$24,000.00. Funds in the amount of \$19,000.00 have been appropriated in the current budget. She suggested that the amount of \$3,214.00 be designated for the balance due on the retirement payment. The following resolution was proposed by Trustee Wilson, 2nd by Trustee Condon:

WHEREAS, it has been ascertained that the anticipated bill for retirement to the State of New York will be some \$24,000. and funds in the amount of \$19,000.00 have been appropriated. BE IT RESOLVED THAT, the amount of \$3,214.00, State Anti-Recession Funds shall be designated to make up the difference.

Sewer Tax Report: Village Attorney Poyzer advised that she had received a copy of a report prepared by Bernard Donegal, Victor, N.Y., which spelled out the amount or percentage of a sewer rent that would apply to an individual home owner for income tax purposes. Clerk indicated that with a quick calculation it would appear that the village residents could apply an 82% sewer exemption. Board agreed that a letter should be written to Mr. Donegal to ask if he would confer with the board and be prepared to indicate a fee for such a service for a proposal.

Tax Sale: Resolution was proposed by Trustee Wilson, 2nd by Trustee Condon and carried, to prepare the Notice of Tax Sale of Taxes unpaid as of February 1, 1978.

Info.by Peterson:

Robert Peterson, Chairman Wayne County Planning Board, discussed the level of funding advising that the amount is raised 40% of last year. He advised that under the regulations that were revised in 1977 by Congress, fewer recipients will be funded

Million:

but that the programs will be larger.
The projected figure by the Fed's is some \$13,000,000, with about \$8 - \$9,000,000. to be allocated to New York State. Mr. Peterson continued that it is expedient that the application must be designed to maximize our needs. Numbers are of the utmost importance. In the past it has been possible to make application for fifteen to twenty (15-20) items, but in this case two to three (2-3) will be adequate. The application must be comprehensive for a program to be spread over a three (3) year period, meaning the expenditure of (for example) over \$100,000. for the first year, over \$50,000. the second and over \$100,000. the following year.

An individual community's chance of receiving funds is very slim, but by grouping together with other communities' needs, there is a possibility of obtaining some five to six hundred

thousand (\$5-\$600,000.00). Mr. Peterson advised that selection will be made by number of

Mr. Peterson reiterated that the "Game must be played according to the rules of the Fed's."

Comments: Mayor Davin commented on the need for improvement of Canal Street itself, curbs and sidewalks; Railraod Avenue and Kent Street, drainage; Historic Preservation area of Market Street might be applicable. Mr. Peterson added that a letter of intent was filed asking for a share for the Village of Palmyra. Excluding the Village of Newark, it will be based on the population factor of the county of Wayne some 60,000. A single County application with a share for the Village of Palmyra may be some \$60,000.00. Mr. Peterson indicated that there is a 312 Program designed for assistance to landlords. Library Needs:

Cass Vande spoke in behalf of the Library Association pointing out the need for ramps or ramp for the handicapped, who find it very difficult now to gain access to the library. In addition, the wiring of the building is inadequate and unsafe. Bathroom facilities are not adapted to use of the handicapped, either with too narrow doors as well as space to enter a wheelchair, or are not large enough to accomodate a wheelchair. Mrs. Vande indicated that some \$5,000.00 would be needed for wiring and revamping of bathroom facilities.

Trustee Wilson asked Mr. Peterson to ascertain if any funds might be available for a Community Center project.

Info.by Robert Peterson advised that the urban areas have first priority Peterin the present C.D. funding. Small communities, he continued have a better chance of repairing homes in the low income area.

Fifty percent (50%) can be used for this type of funding with twenty-five percent (25%) in the area of repairing or rebuilding sidewalks and curbs, with the final twenty-five percent (25%) for a community wide project.

Citizen Mr. Peterson suggested that it might be apropos that a Citizen Comm.: Committee be appointed who would review the applications. Mr. Peterson informed the group that only nine million (\$9,000,000.) will be allocated to the State of New York. He advised that it would be at least a year before the money would be forthcoming. There are two methods of applying, according to Mr. Peterson:
(1) Single application for the Village for a one year (1) yr. funding program, or: (2) Comprehensive application combined with the County of Wayne for a three year (3 Yr.) Funding Project.

David Davin commented that Prospect Drive, needs to be redesigned for better traffic flow. Mayor Davin commented on Railroad Avenue drainage, and the need for Canal Street improvement with curbs and sidewalks. Other suggestions could be insulation for homes, storm windows and doors as well as funds for a Community Center.

Possible Mr. Peterson commented that it might be possible for the Village Funding: of Palmyra to receive \$50,000. to \$100,000.

2 Min. Mayor Davin opened the meeting with a moment of silence. Silence:

Mayor Davin advised that an amendment to the minutes of the Minutes: previous meeting, February 6, 1978, would be in order in relation to the item regarding Heath Consultants, who did the water transmission line survey within the village limits, at which time the cost was about \$300.00 per day for an overall cost of \$5,000.00. It would, therefore, be economical to purchase this piece of equipment for use by the water department to make periodical surveys. Motion by Trustee Reeves, 2nd by Trustee Condon and carried, to approve the minutes of the previous meeting with the above . correction.

Vouchers: Motion by Trustee Reeves, 2nd by Trustee Condon and carried, to approve payment of the vouchers in the amount of \$27,868.89 and authorize the treasurer to draw checks for this amount.

Towpath Manor

Zoning Officer Wideman advised that he and Fire Chief White, together with the Assistant Chiefs, inspected the Senior Inspect.: Citizen Housing, known as Towpath Manor, on February 9, 1976 Zoning Officer Wideman advised that the Fire Department members were impressed with the fire regulations and safety A partial Certificate of Occupancy will be issued features. but later a full occupancy will be given. Fire Chief White and Zoning Officer Wideman both feel that Conifer Develop-ment has done an excellent job in constructing the building, despite the fact that the exterior facade was not as had originally been planned.

Wetlands Dump.of Sludge:

Zoning Officer Wideman advised that he had received a letter from Mr. Stellato, Department of Army Engineers. Mr. Wideman commented that he had spent a day in Buffalo checking with the Corps of Army Engineers, who advised that they were unaware that the State of New York was dumping sludge on the wrong side of the Barge Canal, the south side, rather than the north side. Mr. Wideman continued that he had received other letters protesting the dumping.

Historic Area Applic .:

Zoning Officer Wideman advised that he would like to submit an application to denote the area from Maple Avenue west, some 2600 feet to approximately the property of E. W. Fisher, 439
West Main Street, to be classified in the records of Historical
Area and grounds, for the Towpath Historic Area. This could
then become a Historical Site. The Town of Palmyra, he added, has applied for a grant to help with the Erie Canal Restoration Project.

Town Letter re: Water:

Mayor Davin informed the board that the clerk had sent a letter to the Town of Palmyra informing them that the Village of Palmyra would consider granting up to 50,000 gallons of water per day to a new district providing approval is received from the State Water Resources Commission, the State Comptroller and any other specifications that must be met as prescribed by After approval, the Village of Palmyra the state are in order. would then be in a position to negotiate an agreement.

Value Mgmt.:

Mayor Davin advised that Dr. Ganim, Value Management Consultants have tentatively set a date of March 20, 1978 at 4:00 P.M., at which time they completed first draft of the Policy Manual will be discussed and reviewed.

J.Griffin:

Jerry Griffin, owner of Canaltown Record Shop, East Main St., advised that the snow between his building, 239 East Main St., and Wallace's Paint Shop, 235 East Main St., had not been removed from the Alley Way. He indicated that it was his understanding that according to the lease agreement, the village would remove the snow. Due to the two snow storms, the snow has piled up to the extent that his tenant, who lives upstairs, is unable to get out. Mr. Griffin remarked that it is a fire hazard with so much snow. Trucks would not be able to get to his area on the north side. It appears that someone fills in the areasas soon as he hand-shovels the area out. Trustee Green advised that he would check with Ray Smith, Highway Foreman, to determine if snow can bepplaced in another area.

Pop Vending Machine:

Jerry Griffin advised that he is contemplating placing a "Pop Vending Machine" in front of his store, if there is no village ordinance that would prevent same. Moreover, he added, if he is unable to obtain the proper insurance, he would not place a machine on the pavement in front of his store. He added that he would have a "tin can" machine, not glass. Mayor Davin mentioned that this could cause more "litter" on Main Street. Mayor Davin added that it would be necessary to check if there is an ordinance relative to this type of vending Mr. Griffin added that he needs to increase his business somehow and felt this a good opportunity.

Taxi Service:

Trustee Wilson questioned the "Taxi Service" that he now has. Mr. Griffin informed the board that he has one or two calls a Things, he added, will pick up more in the spring. per week.

Tax Dist.:

Mr. Griffin asked if the assessments had been set on the "Beautification Tax District". Mr. Griffin commented that he had talked with Cliff Williams, coordinator of the Beautification Project in conjunction with the County of Wayne, His, Mr. Griffin's, complaint is that the flower box next to his building has not been replaced and there are no lights in the alley between his building and Wallace's Paint Store. He advised that he should have been contacted before an assessment was made. In regard to the flower box, he would like it build up with brick. Mr. Griffin added that in the southwestern section of Wayne County, there is a rehabilitation of housing. He felt that the Village of Palmyra should try to qualify so that his building might be one of those picked for remodeling.

Mr. McMaster advised that their fee would be approximately \$300.00 for preparation, plus any out of pocket expenses. The report that they would prepare would be signed by the Mayor. In turn this would be submitted to Internal Revenue who would authorize the percentage rate. Reports would be on file in the village office for the public to view.

Mr. McMaster advised that generally a flier or stuffer is sent with the final yearly sewer bill advising the property owner that he may use a certain percentage for his income tax return. 

Firehse R.Sherman Rpts.:

Robert Sherman, Architect, for the firehouse being constructed on Route #31, north side, adjacent to the Village of Palmyra Sewer Disposal Plant, on property which belonged to the Village and had originally been purchased for the placement of the Sewage Disposal Plant, in the event more land might be needed for the site, informed the board that extra problems have arisen in view of the fact that the excavation site had originally been the old Erie Canal Bed and later was filled in with ashes, debris of all sorts. The borings, he commented, showed ashes for about five (5) feet, when in fact they were some ten (10) feet below the ground. The contractor, Mr. Sherman continued, claims some 1,277 cu. yds. of material with trucking and excavation costs amounting to some \$18,538.00. Mr. Sherman indicated that he felt about 75% of \$18,538.00. Mr. Sherman in this figure was reasonable. Because of this extra work, peers had to be placed for the

foundations.

Mr. Sherman commented that Mr. Pulcini supplied some of the fill material as did Cleasons. It would be possible to ask their invoice figures to Iverson Construction. Mr. Sherman mentioned that there is a possibility that Iverson is requesting payment "twice", and therefore, Mr. Sherman feels that some credit should be due.

Mr. Sherman indicated that the Village Board has the option of arguing with Iverson, or the village could pay. Mr. Sherman intimated that as the Architect, he is "caught in the middle" attempting to get the job done fairly and efficiently.

Mr. Sherman did indicate that he felt the contractor should have removed at least one (1) foot of top before starting work.

Soil borings that were taken did not give sufficient information. Trustee Wilson interjected that she felt that Mr. Sherman should attempt to negotiate a fair price.

The second problem has arisen with support of the flooring where the heavy trucks will be stored. Extra peers will be needed. Discussion of appointing an overseer.

Mr. Sherman advised that he did not feel that it would be

necessary, Board thanked Mr. Sherman for his update of the progress of the building.
