The Village received \$3440 for the surplused items approved at the last Board meeting. This will be used towards replacement firearms. (See budget amendment below)

MOTION TO APPROVE THE HIRING OF PART TIME PER DIEM OFFICERS Joshua Fose,

Edwin Resendiz-Ramirez and Kevin Vaughn at \$28.00 per hour was made by Trustee Perry, seconded by Trustee Luke Vote, 4 ayes. CARRIED.

Chief DiNardo explained that per diem, part time officers are hired so they can be used to cover shifts that are vacant as we are down a full-time officer. They are not guaranteed shifts. The budgeted salary is being used and we are not adding extra shifts. It takes three months for the per diem officers to be added to our rosters by NYS. This is why there is a pool of per diem officers if shifts need to be staffed. Having these per diem officers is not a permanent solution but a band aid to provide protection for our residents.

<u>MOTION TO SET PUBLIC HEARING FOR 2024-2025 BUDGET</u> on April 1st at 6:30pm was made by Trustee Denniston, seconded by Trustee Perry. Vote, 4 ayes. CARRIED.
