<u>PUBLIC HEARING FOR CHANGE OF LOCAL LAW 183-7 AND 183-9</u> regarding parking in front of the American Legion at 132 Cuyler Street changing from no parking to parking from 4:00pm-10:00pm starting 20 feet south of the crosswalk and extending south to the end of the curb at 132 Cuyler Street.
