CALL TO ORDER: Mayor Husk called the meeting to order at 6:00 p.m.

EXECUTIVE SESSION: Motion was made and seconded to go into executive session concerning a litigation matter concerning the Code Enforcement Office at 6:00 p.m. Vote 4 ayes. CARRIED.

BUDGET WORKSHOP: The Board took its first look at the 2017-2018 budget. Adjustments were made to the General Fund and by using \$133,185 which is over a third of the fund balance, the tax rate at the close of the meeting was \$13.19 per thousand. Last year's tax rate was \$12.37. The Board reviewed the summary on salaries and quickly looked the Water and Sewer Funds with Mr. McMaster's recommendation regarding May transfers to the water and sewer reserves. The next Budget Workshop is next Monday, Feb. 20.

RESOLUTION: Motion was made by Trustee Luke, second by Trustee Nolan to authorize the Mayor to sign the contracts with MRB for a concept plan, survey and design services for H24 Canal Trail Connector and Basic Services for H27 Canal Terminal Wall Projects. Vote, 4 ayes. CARRIED.

GPS ON POLICE VEHICLES: Mayor Husk reported that he has opened up dialog with Verizon about the GPS system for police cars. He also meet with former mayor Vicky Daly about the CANALNY organization and their work.
